

Community Air Monitoring Program  
7/19/10 through 7/25/10

Community air monitoring data is reviewed and compared to specific NYSDEC/NYSDOH approved criteria, known as “Action Limits”. As a result of this evaluation process, site conditions are categorized into two categories, “Operational Condition” and “Action Condition”. The “Operational Condition” is applicable when the data is below the “Action Limits” noted in the table below. The “Action Condition” occurs when one or more fifteen minute average measurement for Dust (PM<sub>10</sub>), Total Volatile Organic Compounds (TVOC), Naphthalene or Odor Intensity exceeds the background or upwind measurement by the “Action Limits” in the table below. During the period from 7/19/10 through 7/25/10 there were six Fixed and two Portable Air Monitoring locations measuring TVOC and PM<sub>10</sub>. **Fifteen-minute averages for PM<sub>10</sub> and TVOC data remained in the Operational Condition.** However, there were elevated concentrations above the Action Limit as described in the following paragraph.

On Monday, July 19, 2010 there was a period of elevated PM<sub>10</sub> concentrations at Fixed Air Monitoring Site 1 (FAM 1). The elevated concentrations were caused by high relative humidity. All elevated concentrations were reduced below the Action Limit after background subtraction. Therefore, the site remained in the operational condition (see Table 2).
