

Community Air Monitoring Program
08/24/09 through 08/30/09

Community air monitoring data is reviewed and compared to specific NYSDEC/NYSDOH approved criteria, known as “Action Limits”. As a result of this evaluation process, site conditions are categorized into two categories, “Operational Condition” and “Action Condition”. The “Operational Condition” is applicable when the data is below the “Action Limits” noted in the table below. The “Action Condition” occurs when one or more fifteen minute average measurement for Dust (PM₁₀), Total Volatile Organic Compounds (TVOC), Naphthalene or Odor Intensity exceeds the background or upwind measurement by the “Action Limits” in the table below. During the period from 08/24/09 through 08/30/09 there were six Fixed and one Portable Air Monitoring locations measuring TVOC and PM₁₀. **Fifteen-minute averages for PM₁₀ data remained in Operational Condition.**

On Friday, August 28, 2009 there were elevated PM₁₀ concentrations at Fixed Air Monitoring Site 3 (FAM 3) for twelve minutes caused by a laborer sweeping in the vicinity of FAM 3. Background concentrations were not great enough to reduce the elevated concentrations below the Action Limit; However, the elevated concentrations were not associated with ground intrusive activities. Therefore the site remained in the Operational Condition (less than the Action Limit and or were not associated with ground intrusive activities).
